

**UPPER SOUTHAMPTON TOWNSHIP
RESOLUTION #2000-3**

A RESOLUTION OF THE TOWNSHIP OF UPPER SOUTHAMPTON, COUNTY OF BUCKS, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE TRANSFER OF NINE THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$9,500.00) FROM THE EMERGENCY SERVICES CAPITAL FUND TO THE EMERGENCY SERVICES OPERATING FUND AND AUTHORIZATION OF THE DISTRIBUTION OF NINE THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$9,500.00) TO THE TRI-HAMPTON RESCUE SQUAD.

WHEREAS, the Southampton Fire Company No 1 provides fire protection services to Upper Southampton Township; and

WHEREAS, Tri-Hampton Rescue Squad provides emergency services to the residents of Upper Southampton Township; and

WHEREAS, the Southampton Fire Company No. 1 recently renovated its building located at 917 Street Road, Southampton, Pennsylvania 18966; and

WHEREAS, 14% of the renovated building is designed for use by a rescue squad; and

WHEREAS, Tri-Hampton Rescue Squad desires to use the Fire Company's facilities; and

WHEREAS, the Fire Company has requested a contribution from the Rescue Squad for the purpose of establishing a fund for use in the replacement and renovation of the building in the future; and

WHEREAS, the Rescue Squad has requested additional funding from the Township in order to make such contribution to the Fire Company; and

WHEREAS, the Board of Supervisors has determined that it is in the best interest of the residents of the Township to provide additional funding to the Rescue Squad for such use; and

WHEREAS, the Rescue Squad has pledged that it will use its best efforts to increase the level of service and in-service time in Upper Southampton Township from its current level of 55% to 80% in the next five years; and

WHEREAS, the Board of Supervisors has determined that additional funding should be available to the Rescue Squad as long as the level of service and in-service time increases as follows:

<u>Year</u>	<u>Percentage Increase</u>
May 2001	60%
May 2002	65%
May 2003	70%
May 2004	75%
May 2005	80%

WHEREAS, the Board of Supervisors shall annually review the level of service on or about April 15 of said years.

NOW THEREFORE, the Board of Supervisors of Upper Southampton Township, County of Bucks, Commonwealth of Pennsylvania hereby resolve that:

- 1 The provisions of the preamble are true and correct and are fully incorporated hereby by reference
- 2 The amount of Nine Thousand Five Hundred and 00/100 Dollars (\$9,500 00) shall be transferred from Emergency Services Capital Fund 006392 870 to the Rescue Squad Operating Fund 008492 950
- 3 The payment of Nine Thousand Five Hundred and 00/100 Dollars (\$9,500 00) from the Rescue Squad Operating Fund 008492 950 shall be made immediately to the Tri-Hampton Rescue Squad.


4 The Board of Supervisors will review the level of service and in-service time in mid-April of 2001, 2002, 2003, 2004, and 2005 for the purposes of evaluating future requests for funding and will endeavor to continue to seek contributions as set forth in Paragraph 3 in said years as long as the level of service and in-service time increases as provided for in this Resolution

5 This Resolution shall become immediately effective upon its enactment.
