RESOLUTION #2001-18

A RESOLUTION OF UPPER SOUTHAMPTON TOWNSHIP, County of Bucks, Commonwealth of Pennsylvania, fixing the tax rates for the year 2002.

BE IT RESOLVED AND ENACTED, by the Board of Township Supervisors, Upper Southampton Township, in the County of Bucks, Commonwealth of Pennsylvania:

That a tax be levied as follows on all real property within Upper Southampton Township, which is subject to taxation, for the fiscal year 2002:

Tax rate for general purposes, the sum of on each dollar of assessed valuation, or the sum of on each hundred dollars of assessed valuation:	11.55 mills 115.5 cents
For debt purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	9.75 mills 97.5 cents
For street lighting purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	3.85 mills 38.5 cents
For fire hydrant purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	.50 mills 5 cents
For fire protection purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	4.2 mills 42 cents
For park & recreation purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	6.18 mills 61.8 cents
For library purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	7.00 mills 70.0 cents
For rescue squad purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	.9 mills 9 cents

Tax rate for rescue squad	.90	9.0




