

**UPPER SOUTHAMPTON TOWNSHIP
RESOLUTION # 2001-4**

A RESOLUTION OF THE TOWNSHIP OF UPPER SOUTHAMPTON, COUNTY OF BUCKS, COMMONWEALTH OF PENNSYLVANIA ESTABLISHING THE COMPENSATION OF THE TAX COLLECTOR FOR THE FOUR YEAR TERM FROM 2002 THROUGH 2005

WHEREAS, Upper Southampton Township is a Township of the Second Class in the County of Bucks, Commonwealth of Pennsylvania; and

WHEREAS, it is the responsibility of the Board of Supervisors of Upper Southampton Township to establish the compensation of the Tax Collector for the four year term from 2002 through 2005.

NOW THEREFORE BE IT RESOLVED, the compensation for Upper Southampton Tax Collector for the service of collecting all duly authorized tax bills as listed in the resolution as follows:

THAT compensation of the Tax Collector of Upper Southampton Township for the year 2002 is fixed at One and 42/100 Dollars (\$1 42) per tax parcel for Real Estate Taxes, and eighty-six cents (\$0 86) per tax parcel for Garbage and Refuse, and Four and 76/100 Dollars (\$4 76) per parcel for Interim Tax Collections

THAT compensation of the Tax Collector of Upper Southampton Township for the year 2003 is fixed at One and 45/100 Dollars (\$1 45) per tax parcel for Real Estate Taxes, and eighty-eight cents (\$0 88) per tax parcel for Garbage and Refuse, and Four and 90/100 Dollars (\$4 90) per parcel for Interim Tax Collections


THAT compensation of the Tax Collector of Upper Southampton Township for the year 2004 is fixed at One and 49/100 Dollars (\$1 49) per tax parcel for Real Estate Taxes, and ninety-one cents (\$0 91) per tax parcel for Garbage and Refuse, and Five and 05/100 Dollars (\$5 05) per parcel for Interim Tax Collections


THAT compensation of the Tax Collector of Upper Southampton Township for the year 2005 is fixed at One and 53/100 Dollars (\$1 53) per tax parcel for Real Estate Taxes, and ninety-four cents (\$0 94) per tax parcel for Garbage and Refuse, and Five and 20/100 Dollars (\$5 20) per parcel for Interim Tax Collections.

This Resolution shall become immediately effective upon its enactment
