

**RESOLUTION #2009-15**

**A RESOLUTION OF THE TOWNSHIP OF UPPER SOUTHAMPTON, COUNTY OF BUCKS, COMMONWEALTH OF PENNSYLVANIA FIXING THE TAX RATES FOR THE YEAR 2010**

**BE IT RESOLVED AND ENACTED**, by the Board of Supervisors of Upper Southampton Township, County of Bucks, Commonwealth of Pennsylvania:

That a tax be levied as follows on all real property within Upper Southampton Township, which is subject to taxation, for the fiscal year 2010:

Tax rate for general purposes, the sum of on each dollar of assessed valuation, or the sum of on each hundred dollars of assessed valuation:	7.950 mills 79.500 cents
For debt purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	1.930 mills 19.300 cents
For street lighting purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	1.385 mills 13.850 cents
For fire hydrant purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	.125 mills 1.250 cents
For fire protection purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	1.250 mills 12.500 cents
For park & recreation purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	3.040 mills 30.400 cents
For library purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	1.975 mills 19.750 cents
For rescue squad purposes, the sum of on each dollar of assessed valuation, or the sum of on each one hundred dollars of assessed valuation	.475 mills 4.750 cents

For open space purposes, the sum of  
on each dollar of assessed valuation, or the sum of  
on each one hundred dollars of assessed valuation



Tax rate for library	1.975	19.750
Tax rate for rescue squad	.475	4.750
Tax rate for open space	.750	7.500

That any part of a resolution conflicting with this resolution is repealed.


