

**4. A statement that the municipality desires revival of the authority as a body politic and corporate for an additional term not exceeding 50 years:**


Upper Southampton Township desires that the Upper Southampton Sewer Authority be revived as a body politic and corporate for an additional term that ends on June 30, 2011.


**5. A statement that the filing of the municipal statement of revival has been authorized and approved by the municipal authorities of the municipality by resolution:**
